



Texas has promulgated regulations that mandate that all public water suppliers have a program to require backflow prevention devices be installed to protect against contamination of public water supplies. Effective January 1, 1996, the Texas Commission on Environmental Quality (TCEQ) required that all public water systems comply with the Texas Annotated Code, Title 30, Chapter 30. The TCEQ began full enforcement of these regulations and evaluates public water systems for compliance through its annual public water system inspection program. All systems found without a program or with an inadequate program may risk their Superior Water Rating or incur fines from the TCEQ of up to \$10,000 per day until an approved program is in place.
